## **Participating Organization Agreement**

1. GRI Financial reserves the right to refuse or revoke the enrollment of any organization in the Rewards program (“Program”).
2. GRI Financial retains the right to indicate to the public that the Organization is an authorized participant of the Program and in connection therewith may use the trademarks, service marks, and trade names (“Marks”) of the enrolled Organization.
3. While enrolled in the Rewards program, the Organization retains the right to indicate to the public that it is a part of said Program. The Organization has rights to use the trademarks, service marks, and trade names (“Marks”) of the Program. However, all Marks used by the Organization shall be exact copies of those used by GRI Financial or shall first be submitted to GRI Financial for approval of design, color and other details. The Organization shall not use the Marks in any manner that would be inconsistent with or damaging to the GRI Financial or Payfinity name and/or reputation.
4. The Organization may not assign this Program or any rights or obligations hereunder, directly or indirectly by operation of law or otherwise, without the prior written consent of GRI Financial.
5. This Program shall be governed by the laws of the State of Florida, without reference to conflict of law principles. Any disputes arising out of this Program shall be received by binding arbitration in Palm Beach County, Florida in accordance with the rules of the American Arbitration Association.
6. GRI Financial shall not be liable for any damages, including but not limited to, direct or indirect damages, incidental, special or consequential damages, loss of profits or revenue, or interruption of business in any way arising out of or related to the Program, regardless of the form of action, whether in contract, tort (including negligence), strict product liability or otherwise, even if GRI Financial or any representative of GRI Financial has been advised of the possibility of such damages.
7. When a supporter of the Organization makes a qualifying purchase at a participating merchant, the participating merchant, pursuant to its contract with GRI Financial, will provide GRI Financial or Payfinity with a percentage of such purchases, and GRI Financial or Payfinity shall provide such contributions to the Organization in full.
8. GRI Financial or Payfinity’s obligation to deliver funds under the Program is conditional upon GRI Financial or Payfinity receiving funds from qualifying merchants. GRI Financial nor Payfinity make representations or warranties, express, implied, statutory or otherwise, with respect to the Program or as to any matter whatsoever. In particular and without limitations, GRI Financial and Payfinity disclaim any and all warranties of merchant liability, satisfactory quality, fitness for a particular purpose or non-infringement of third-party rights.
9. “Confidential Information” shall mean any trade secrets, confidential data, or other confidential information of GRI Financial, Payfinity or the Organization. Neither GRI Financial, Payfinity nor the Organization shall use any confidential information of the other for any purpose not authorized under this contract, and shall not disclose any such confidential information to any third party except as required by law. No confidential information is stored on the cards.
10. This agreement shall remain in effect until terminated by either party upon thirty (30) days written notice.
11. GRI Financial reserves the right to discontinue or alter the terms of this Program, including but not limited to, the participating merchants, the contribution percentages, and the card types that are accepted by merchants, at any time without prior notice.
12. Rewards Cards will not expire, unless an agreed date has been set by either party, for the calendar year of such program. New cards will be issued for the following year and at that time enrollment in the Program will be revised and/or renewed.
